Global Perspectives on Advancing Animal Law

This pre-recorded session brings together a diverse panel of international experts to examine emerging issues and innovations in global animal law. Topics include France's préjudice animalier concept, which recently extended aspects of legal personhood to companion animals in two court rulings; collaborative strategies for strengthening animal protection in Zimbabwe; a comparative analysis of various European jurisdiction's representation of animal interests in legal proceedings; and a timely discussion on the legal safeguarding of animals during natural and humanitarian disasters.
